

ROPPA CALLS ON PRIME MINISTER BLAIR AND G8 TO LISTEN TO FARMERS

The West African Network of Smallholder Farmers' Organisations and Agricultural Producers – ROPPA in its French acronym – wrote to Tony Blair and G8 ministers in July.

The letter was launched at the UK Food Group and Greyfriars Kirk MAKE HUNGER HISTORY event prior to the Make Poverty History rally in Edinburgh.

In the upcoming round of trade negotiations, ROPPA is calling for:

- an immediate halt to negotiations on Economic Partnership Agreements until there is a level playing field in terms of trade:
- the inclusion of smallholder farmers in developing and implementing plans and programmes for poverty reduction

 something they say has been notably absent in the PRSP (Poverty Reduction Strategy Papers) process; and
- coherent policies that will address the espoused concern for Africa and will change the inequitable world order, which is controlled overwhelmingly by G8 countries and their corporations.

SELECTED UK FOOD GROUP ACTIVITIES 2005

UK Government Department for International Development (DFID) consultation "Productivity growth for poverty reduction: an approach to agriculture"

The UKFG has engaged with DFID in its consultation process on developing its new agriculture policy, in particular, facilitating responses from CSOs to the 14 background Working Papers.

In the final draft, there is a need for greater clarity about scope, definitions and linkages; it prioritizes high potential growth areas and market access but neglects non-market agriculture. There's also an unsubstantiated pro-GM technology approach.

The UKFG submitted its response to the DFID consultation in September, based on consultations within the Sustainable Agriculture and Trade Working Group. The five-page submission is available at www.ukfg.org.uk/ (Click on 'UKFG Publications').

2nd November, 'Trade Justice not Free Trade' Mass Lobby, 12 midday – 6:00 pm, London This year, UK NGOs have been mobilising their memberships through the 'Make Poverty History' campaign to achieve a better deal for developing countries at the upcoming WTO Ministerial meeting.

There was tremendous public support at previous rallies, in April in London and July in Edinburgh, and we expect a good turnout at the upcoming mass lobby of Whitehall in November.

To push the message for trade justice not free trade, people are lobbying their MPs with the messages (1) Stop pushing poor countries to open their economies and (2) Respect poor countries' right to decide their own trade policies in order to help end poverty and protect the environment. NEW!! UK Food Group publication 'Achieving fairness in trading between supermarkets and their agrifood supply chains' by Anne Tallontire and Bill Vorley

What are the prospects for fair trade to become the norm rather than the exception for trading between supermarkets, their suppliers, and farmers at home and around the world? That is the question asked in this paper, which comes at a time of widespread scrutiny of UK supermarkets and

their influence on the livelihoods of food producers and suppliers. The paper reviews the opportunities and risks in incorporating fairness into supermarkets' trading practices. It was commissioned by the UK Food Group's Trans National Corporations Working Group to inform member organisations' campaigning strategies and to propose a new agenda for future research. Food Sovereignty debate in the UK

In June this year the UK Food Group held a Food Sovereignty seminar to facilitate debate on the principles of food sovereignty among UK Food Group members. This was to further understanding about how the Food Sovereignty policy framework addresses hunger eradication and poverty reduction.

The keynote presentation was given by Michael Windfuhr, based on a new FIAN/ITDG report 'Food Sovereignty: towards democracy in a localized system'. It was agreed that more discussion is needed to define the modalities of how to implement the Food Sovereignty policy framework. Also, widening its endorsement by civil society and government needs addressing. The UKFG will continue to facilitate debate on this issue together with European and International partners.
